# All U.S. exempt employees participate in Job Evaluation and Classification (JEC) Project

(Questions about the JEC Project? See page 8.)

During the next several months, all of Digital's exempt employees in the U.S. will participate in the Job Evaluation and Classification (JEC) Project. Each will complete a short Job Overview Questionnaire (JOQ) describing the content of their jobs, and a few will complete a more in-depth survey called the Job Profile Questionnaire (JPQ). The questionnaires are being used to evaluate work content, not individual performance in a job.

Managers will review the completed questionnaires and assess the content of the work currently being performed before classifying employees. A new on-line Job Information System (JIS) will enable managers to match their employees' job content to an appropriate job description in JIS. Once this process is completed, every exempt employee in the U.S. will be assigned a new job code, job description, and place in the new job structure. All U.S. exempt employees will be classified by May 1, 1988.

"We are calling upon all U.S. exempt employees to participate in this critical stage of the JEC process by accurately completing the questionnaires," says Harvey Weiss, U.S. Compensation and Benefits Committee (USCBC) co-chair and vice president of U.S. Sales Operations. "Employees have a unique opportunity to

be directly involved in a process which will influence how they are positioned in Digital's new structure. Data from the questionnaires will help us develop and validate Digital's job descriptions."

During the first phase of the JEC classification process, which began in November, job descriptions existed only for benchmark jobs (selected jobs used for making comparisons with jobs in

other companies). To create descriptions for all jobs, several thousand employees are also completing a more detailed Job Profile Questionnaire (JPQ) to describe their work. By the end of the classification process, appropriate job descriptions will exist for all exempt work.

"JEC will change the way we define jobs in Digital, and all exempt employees will be affected by these changes," says JEC Implementation Manager Kathy Robbins. "This change is necessary for our growth and

success as a company. JEC is a highly participatory project, an opportunity for everyone to get involved. We encourage people to join with us in this effort, ask questions and seek out more information from their manager and Personnel."

# Some tuition payments are now taxable

Effective Jan. 1, tuition payments made to employees for courses that are not required for their current job will be subject to tax withholdings because Section 127 of the Internal Revenue Code has expired.

Tuition payments for courses that are defined as "job required" will continue to be non-taxable. Those courses identified as non-taxable on the Application for Education and Training forms will still be processed through Petty Cash sites.

The tax status of a course defined as "career related" can be determined by using the guidelines on the Application for Education and Training form. If a course is taxable, the form will be forwarded to Corporate Payroll for processing. In that case, the check issued to the employee from Corporate Payroll will have taxes withheld from the original amount and will be reflected as income on

# Holiday turkeys distributed to local charities

Thanks to the generosity of Digital employees, the holiday season was a little brighter for some of the area's needy. Out of some 47,000 turkeys distributed to employees, more than 1,000 were donated by employees to various charities in eastern Massachusetts and southern New Hampshire.

The turkey distribution program is administered by Corporate Employee Services and Recreation. Says Manager Sheila Fantozzi, "The turkeys were donated to agencies such as Freedom House in Roxbury, the Worcester Food Bank, and the Nashua Soup Kitchen. Organizations like the Elks lodges in Derry and Salem (N.H.) and Hudson (Mass.), as well as area churches, also received turkeys." These organizations, and others like them, received donated turkeys based on requests received by Corporate Employee Services and Recreation.

Some of the agencies receiving the 12- to

14-pound hen turkeys served them to the hungry for Christmas dinner. Other turkeys were distributed in food baskets.

"When employees write 'charity' on their turkey distribution card, the turkeys are put into a pool, so to speak," explains Sheila. "We then allocate the turkeys to different charities. The organizations can pick them up or, if there are a lot of turkeys going to one place, we can deliver them."

Sheila adds that employees who want to donate their turkeys to a particular charity are responsible for "seeing to it that it gets there. Much as we'd like to help, we're not in any position to donate one turkey to Agency A, one turkey to Agency B, and so on."

While turkeys are distributed at every Digital site in New England, some sites in other parts of the country receive either turkeys or a voucher card good toward the purchase of a turkey at a local supermarket.

## Questions about JEC? Here are some answers

As thousands of U.S. exempt employees begin to participate in the JEC process, many questions are being asked. Kathy Robbins, JEC Implementation manager, answers some of the most common ones.

# What direct benefits can employees expect from JEC?

There are a number of direct benefits. An employee's job will be appropriately classified using new tools and methods that have been developed to help ensure consistency across all Digital organizations. This means that similar jobs, whether performed in Engineering, Finance, Personnel, Manufacturing, Marketing or the Field, will be defined consistently and paid competitively.

JEC will help employees in their career development at Digital. Employees and managers will have access to new job descriptions, providing a clearer picture of the scope of job tasks within each job function. We expect that employees will better understand their relative position in Digital and the requirements leading to

potential career opportunities.

# What changes can I expect as a result of the project?

All exempt employees can expect changes in their job description, job code and salary range. Jobs will be coded differently but the work itself will not change. Current pay will not be reduced, and employee benefits will not change as a result of JEC.

### Should I expect a change in pay?

No, you should not expect your pay to change. JEC's goal is not to change current salaries in Digital. You can, however, expect your salary range to change which, coupled with your performance, may affect your salary over time.

#### Why am I being asked to complete a questionnaire? Couldn't my manager do it for our group?

The questionnaires function as the most important vehicles for gaining an accurate description of the real content of your job. As a Digital employee you are in the best position to provide the

most accurate and comprehensive information about your work.

### What will be done with the questionnaires after they are completed?

Managers will keep the Job Overview Questionnaires (JOQs) and match your work content to an appropriate job description by using the new online Job Information System (JIS). This will then lead to a new classification (new job code, job description, salary range, etc.).

The more detailed Job Profile Questionnaires (JPQs), completed by a small sample of exempt employees, will be sent to Personnel for processing. They will be used to create new job descriptions for jobs not currently in the JIS.

# When and how will I learn about the results?

All U.S. exempt employees will be classified by May 1, 1988. Once your classification is determined, your manager will discuss your new job code and job description with you. New job codes for all employees are proposed to be effective in July 1988.

# Funding available for advanced development projects

The Corporate Research and Advanced Development Committee (RAD) has funds available to support innovative advanced development projects from Digital employees in any area of technology of interest to Digital. Funding will be available from Q1 of FY89 to Q1 of FY90.

The deadline for submissions is March 4. If this deadline is missed, employees must wait until the next funding cycle, which has a deadline of September 1988. This next funding cycle will not begin until January 1989.

In the past, the committee has looked more favorably on one-year proposals under \$300,000 in which the proposer does a substantial portion of the actual work.

In addition to normal funding, RAD also will support proposals in a theme area. This year's theme is "I/O Performance and Reliability."

The three-year JEC project is developing new tools and systems to ensure that Digital maintains a consistent, credible and responsive method of evaluating work and classifying employees into jobs. The project will result in a new job structure in which U.S. exempt jobs will be defined consistently across all Digital organizations and priced competitively with the outside market.

In response to Digital's rapid growth and organizational change, the USCBC and the Personnel Management Committee (PMC) chartered the JEC project 18 months ago to create one consistent method of evaluating work and classifying exempt employees. As

the largest personnel project in Digital's history, JEC has already involved hundreds of line managers and thousands of U.S. exempt employees across all functions.

JEC is currently focusing on the exempt population. After the new process has been implemented, Digital will determine whether a similar job evaluation and classification project should be undertaken for non-exempt work.

Over the next several months employees will learn more about the JEC project through staff meetings and other internal communications.
