Pursuant to a vote of the citizens of the Town at the last March meeting, we submit herewith a new valuation of the town, showing in detail the Poll, Personal and Real Estate tax as assessed May 1, 1888. It should be borne in mind by tax-payers generally, that it is a very difficult matter to estimate correctly the value of real estate, for the purposes of taxation. In a town like ours, there is but little change from year to year, in the value of property, except in cases where improvements have been made by the erection of buildings, or the laying out of new ways or streets. The actual cost of the land and buildings must be taken as the basis of calculation almost entirely, except in so far as location may become more or less valuable, and where changes have been made from the former valuation of the town, it is the result of due consideration on the part of the Assessors. We have traveled over every farm in town, seen every pasture and wood lot and equalized values to the best of our ability.
